1. Purpose of survey

In order to place FDK products which comply with the requirement of FDK group specified chemical substances list (hereinafter called "FDK list") on the market, FDK aims to grasp chemical information of procured products and their packaging by using this survey, and prevent from containing the banned chemical substances demanded by the market in FDK products.

2. Scope of survey

This survey applies to FDK procured parts and their packaging materials.

Regarding the packaging materials, the packaging materials specified by FDK is only target material of survey.

3. General requirement

(1) Banned chemical substances

FDK procured parts and their packaging materials should satisfy the requirement of the standard of banned substances in FDK list.

(2) Submission of the survey documents

Suppliers should prepare the survey document according to the instruction of this manual and submit to FDK.

4. Terms and definition

(1) Procured parts (or deliverables)

It means all parts constituting FDK products, describing "procured parts" in this manual, while suppliers should interpret this term to deliverable.

(2) Products

Products contain following three type of products.

- a) Such products that are designed, manufactured and sold by FDK
- b) Such products that are designed and manufactured by third party under commission from FDK and are sold with bearing FDK trademark.
- c) Such products that are designed and manufactured by FDK under commission from third party.
- (3) Packaging materials

It is such materials that is used for wrapping, packing or packaging of FDK procured or manufactured products.

For example, cardboard boxes or wrapping bands are typical packaging material, in addition,

ink, paint, labels and adhesives are also included in packaging materials.

(4) Product contained chemical substances

All chemical substances that are contained in FDK procured parts, products and packing materials.

(5) Contain

"Contain" means certain chemical substances (including impurities) are, whether intentionally or not, added, filled, mixed or adhered to FDK procured parts, products and packing materials.

(This term also means that chemical substances are unintentionally mixed or adhered to products during production process.)

(6) Intentional addition

Deliberate use in the formulation of Deliverables where its presence is desired to provide a specific characteristic, appearance or quality regardless of concentration of the chemical substance.

(7) Material

Homogeneous material which cannot be decomposed furthermore or composite material which can be regarded as homogeneous in order to fulfill its specific function(s), for which it is set or formed at particular position.

(8) Impurities

This term indicates substances which are contained in natural materials and cannot be technically removed completely by refinery processes as industry materials, or substances which are generated in synthetic reaction and cannot be technically removed completely.

(9) Preparation

A mixture or solution composed of two or more substance.

(E.g. adhesives, plating solution, coating materials)

(10)Chemical product

Chemical substance and/or mixture.

(11)Chemical substance

A chemical element or compound, existing in nature or is obtained through a manufacturing process.

(12)Mixture

A mixture intentionally comprising two or more chemical substances.

(13)Article

An item of specific shape, appearance or design created during manufacturing which substantially determines functions in final use rather than functions provided by its chemical composition.

(14)Acceptable limit

Maximum concentration in ppm never be exceeded of a target contained chemical substance in a material which cannot be separated into different materials mechanically (a homogeneous material).

(15)Content rate

Concentration of a chemical substance, used unit of [ppm] (weight ratio, 1 ppm is one-millionth), or used of [wt%] (weight ratio, 1 wt% is one-hundredth).

(How to calculate of the content rate in each specified substance are referred to the annotation of each table.)

(16)CAS number

A registration number for a chemical substance used in the chemical substances registration system in the CAS (Chemical Abstract Service) which was established by the American Chemical Society. It is also called as a CAS number.

(17)Component

A component is a portion of a part and is made of such material that cannot be separated into different materials mechanically (a homogeneous material). The names of components to be used are those used in specification for delivery, drawings, or the like.

(18)FDK group specified chemical substances list (abbreviated to FDK list)

"FDK list" is determined by FDK and contains the list of Banned substances, Reportable substances, Prohibited substances in manufacturing process and Prohibition about purchased battery and battery material.

5. Survey contents

FDK will request suppliers to submit following documents about information of containing chemical substances in procured products and their packaging to FDK, so suppliers should submit following applicable documents.

- a) Certificate of Products contained chemical substances
- b) Questioners of contained chemical substances provided by JAMP (Joint Article Management Promotion-Consortium): select chemSHERPA-AI or chemSHERPA-CI
- c) Components constituent table
- d) Confirmation of change of FDK group specified chemical substances list
- e) Confirmation of change of chemSHERPA
- f) Certificate of no containing specific substances
- g) Subsidiary documents (E.g. Analysis report, SDS or so)
- 6. How to fill and submit the survey documents

Suppliers should fill and submit the survey documents according to following procedures.

a) Certificate of Products contained chemical substances (see appendix 1)

All supplier should guarantee that chemical substances in procured products and their packaging to FDK satisfy the requirement specified in FDK list. If some suppliers have their own standard of product contained chemical substances, and procured products meet to the supplier's standard, FDK will regard the products provided by such suppliers also meet to FDK's standard. (We believe the essential is not some differences between FDK's and supplier's standard but the activity and effort allow our products complying environmental provision such as RoHS, REACH, POPs or so.)

In addition, all supplier should guarantee the obligation to report if procured products contain SVHC candidate materials or may be influenced by certain change like 4M change. Hence, basically, all supplier should provide this document just once when our business started. (Such supplier that did not yet provide this document in the past should provide to FDK.)

- 1) Fill in company name and company seal
- 2) Fill in address, name of representative (signature), contact name (signature), department name and phone number.
- 3) Send by paper or digital form (PDF)
- b) Questioners of contained chemical substances provided by JAMP: select chemSHERPA-AI or chemSHERPA-CI

All suppliers should submit this form for reporting condition of contained chemical substances in procured products and their packaging to FDK as referring below.

1) Use chemSHERPA-AI for assembling parts or components and use chemSHERPA-CI

for raw material, material and chemical material.

2) The form of both chemSHERPA-AI and chemSHERPA-CI can be downloaded from following URL

JAMP (Joint Article Management Promotion-Consortium): https://chemsherpa.net/

- Send back data file of chemSHERPA by e-mail after converting to XML format.
 Note: Addition of compliance information is voluntary.
- c) Components constituent table (see appendix 2)

As a questioner of contained chemical substances, chemSHERPA is the official form, however Components constituent table is permitted to provide in only unavoidable circumstance after discussion with FDK.

According to the sample form of appendix 2, fill in necessary information.

Note: Following documents should be provided just when FDK will ask submission.

- d) Confirmation of change of FDK group specified chemical substances list (see appendix 3-1)
- e) Confirmation of change of chemSHERPA (see appendix 3-2)

The version of both FDK list and chemSHERPA would be revised regularly. In case of revision, FDK will send important change notice to suppliers, please confirm the change notice and send back information to FDK.

If nothing is applicable to the change notice in procured products, send buck of information is not always necessary, however, in this case, FDK will regard the supplier guarantees confirming the change notice and guarantees also no applicable substances in products.

f) Certificate of no containing specific substances (see appendix 4)

This document is certificate of no containing specific substances in procured products and will be requested when certain restricted substances will be published by EU commission or other legal organization. Quick respond is appreciated when FDK may ask supplier submitting this document.

Basically, substances which are listed in FDK list are not the target substances of this certificate.

g) Subsidiary documents (Analysis report, SDS or so)
 FDK may request suppliers to provide such subsidiary documents like the analysis report or
 SDS if necessary, so great assistance of suppliers is appreciated.
